**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On July 2, 2014, the agency received a report regarding two children, ages seven-years-old and nine-years-old, brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation regarding the children's suspicious injuries.

Medical professionals determined the children sustained significant injuries as a result of child abuse. The mother's boyfriend was arrested and criminally charged with two counts of Child Abuse-High Probability/Great Harm. The mother's boyfriend was found guilty of one count of Child Abuse-High Probability/Great Harm.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the children by the mother's boyfriend. Medical professionals determined the children sustained significant injuries related to the child abuse incident. The agency also found a preponderance of the evidence to substantiate maltreatment of neglect to the children by the mother. The mother did not seek medical attention for her children. The children were deemed unsafe, taken into Temporary Physical Custody, and placed in out-of-home care. The case remained open to provide ongoing case management services.

At the time of the incident, the children resided with their mother and the mother's boyfriend. The mother's boyfriend has a two-year-old child from a previous relationship who had weekly visitation with him. The family also had an adult roommate who resided in the home at the time of the incident. The children's biological fathers have no contact with the children and their whereabouts are unknown.

On December 14, 2012, the agency screened-in a CPS Report alleging sexual abuse to a five-year-old male child by the mother's boyfriend (current alleged maltreater). An assessment was completed by the agency and the allegation of sexual abuse was unsubstantiated.

On October 17, 2013, the agency screened-out a CPS Report.

On October 22, 2013, the agency screened-in a CPS Report alleging emotional and physical abuse to the eight-year-old (now nine-year-old) female child by the mother. An assessment was completed by the agency and the allegations of emotional and physical abuse were unsubstantiated.

On November 6, 2013, the agency screened-in a CPS Report alleging sexual abuse to the eight-year-old (now nine-year-old) female child by an unknown maltreater. An assessment was completed by the agency and the allegation of sexual abuse was unsubstantiated.

On January 23, 2014, the agency screened-in a CPS Report alleging physical abuse and neglect to the eight-year-old (now nine-year-old) female child and physical abuse to the seven-year-old male child by the mother and mother's ex-husband. An assessment was completed by the agency and the allegations of emotional and physical abuse were unsubstantiated.

On January 30, 2014, the agency screened-out a CPS Report.

On January 31, 2014, the agency screened-out a CPS Report.

On March 18, 2014, the agency screened-out a CPS Report.

On April 22, 2014, the agency screened-in a CPS Report alleging physical abuse to the eight-year-old (now nine-year-old) female child and neglect to a two-year-old female child (biological child of the current alleged maltreater) by the mother's boyfriend (current alleged maltreater). An assessment was completed by the agency and the allegations of neglect and physical abuse were unsubstantiated.

On April 28, 2014, the agency screened-out a CPS Report.
