On September 7, 2016, the agency received a report that a 4 month old infant was brought to the hospital due to seizures. Medical professionals who examined the child suspected head trauma due to the child's presenting symptoms, so the child was transported to another hospital. Law enforcement was contacted and initiated a criminal investigation regarding the child's suspicious injuries. Medical personnel diagnosed the infant with Physical Abuse-Abusive Head Trauma. As a result of law enforcement's investigation, the mother's boyfriend was arrested and criminally charged with First Degree Reckless Injury, Child Abuse-High Probability/Great Harm and Bail Jumping. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty. Findings by agency, including maltreatment determination and material circumstances leading to incident:					
The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the mother's boyfriend. Medical professionals determined the infant sustained head injuries and diagnosed the child with Abusive Head Trauma. The infant was deemed unsafe and taken into Temporary Physical Custody. Upon discharge from the hospital, the infant was placed in out-of-home care with a relative provider.
