On February 13, 2018, the agency received a report regarding a 1-month-old infant with multiple injuries sustained while residing in the hospital after his premature birth. Law enforcement was contacted and initiated a criminal investigation. Medical personnel determined the injuries were non-accidental in nature. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by a hospital staff member. Medical professionals determined the injuries sustained by the infant were non-accidental in nature. The agency facilitated a protective plan with the hospital while the infant remained there until discharge. Upon discharge, the infant was deemed safe in the care of his mother and father and the protective plan was terminated. The agency closed the case upon completion of the Initial Assessment.
