Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On August 6, 2021, the agency received a report regarding a 1-year-old infant found deceased in his home. (The agency responded immediately upon receipt of the report. Due to a technical issue, the notification was not received until October 4, 2022.) Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child's death was due to ingesting controlled substances. As a result of law enforcement's investigation, the child's father was criminally charged with Neglect of a Child, Consequence is Death. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the father and insufficient evidence to substantiate physical abuse of the infant by the father. The agency deemed the infant's sibling unsafe and initiated a Protective Plan. Subsequently, the Protective Plan was terminated, and the infant's sibling was taken into Temporary Physical Custody and placed with relatives. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
