On April 28, 2022, the agency received a report regarding a 10-year-old who was reported missing on April 24, 2022 and found deceased on April 25, 2022. Law enforcement was contacted and initiated a criminal investigation. As a result of law enforcement's investigation, an individual was referred for charges. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.
