**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On August 30, 2023, the agency received a report regarding a 1-month-old infant brought to the hospital and pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the death to be accidental. No criminal charges have been filed on this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office determined the death to be accidental. The Initial Assessment completed by the agency found insufficient evidence to substantiate physical abuse of the infant by an unknown maltreater. The agency determined the infant's sibling safe, and the sibling remained with the mother and father. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

On September 3, 2019, the agency screened-in a CPS Report alleging neglect to the infant's now adult half-sibling and now 11-year-old half-sibling by the mother and the mother's ex-significant other. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On October 2, 2017, the agency screened-in a CPS Report alleging neglect to the infant's now adult half-sibling, 15-year-old half-sibling and 11-year-old half-sibling by the mother and physical abuse to the now 15-year-old half-sibling by the mother. An assessment was completed by the agency, and the allegations of neglect and physical abuse were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On May 13, 2016, the agency screened-in a CPS Report alleging neglect to the infant's now adult half-sibling, 15-year-old half-sibling and 11-year-old half sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On May 29, 2015, the agency screened-out a CPS Report.

On August 21, 2012, the agency screened-out a CPS Report.

On March 12, 2008, the agency screened-in a CPS Report alleging neglect to the infant's now adult half-sibling and now 15-year-old half sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On January 4, 2008, the agency screened-out a CPS Report. The agency provided the family with a referral to voluntary services.

On June 12, 2006, the agency screened-out a CPS Report.

On July 11, 2005, the agency screened-in a CPS Report alleging neglect to the infant's now adult half-sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On May 19, 2004, the agency screened-out a CPS Report.
